ADVERTISEMENT FOR BIDS**

The City of Hermitage will receive sealed bids for the construction of **2008-2009 CDBG Roadway Improvements (Rombold Road Area) – Contract No. 09-02 (A)**, which consists of storm sewer replacement, roadway restoration and cleaning & televising of existing storm lines along Rombold Road in Hermitage, Pennsylvania, until **2:00 p.m.**, local time on **Wednesday, March 17, 2010** and sealed bids will be publicly opened and read aloud immediately following the scheduled closing time for the receipt of bids. Bids will be received at the Office of the City Manager, Hermitage Municipal Building, 800 North Hermitage Road, Hermitage, PA 16148. Bids received after the above stated time will be returned unopened. Faxed bids will not be accepted.

Bidding Documents, including Drawings, Project Manual and Bid Forms, are available for examination, and must be obtained at the office of Herbert, Rowland & Grubic, Inc. (HRG) 3755 East State Street, Hermitage, Pennsylvania 16148 **after March 3, 2010**, at a nonrefundable cost of \$100.00. Documents will be **mailed standard 2<sup>nd</sup> day Fed Ex** at an additional cost of Twenty-Five Dollars (\$25.00) per set payable separately. There will be a **Pre-Bid Meeting at 10:00 a.m., Thursday, March 11, 2010** at the Hermitage Municipal Building. Only plan holders of record are eligible to bid. Each bid must be accompanied by a Certified Check, Cashier's Check, or Bid Bond in the amount of 10% of the bid made payable to the City of Hermitage. The successful bidder will be required to submit a 100% Performance Bond, 100% Payment Bond and 100% Maintenance Bond.

Prevailing wages established under the Pennsylvania Prevailing Wage Act will apply to this contract.

All reporting requirements of the American Recovery and Reinvestment Act of 2009 (ARRA) will need to be met by the selected contractor as indicated in the Project Manual.

The City of Hermitage Advertisement and Procurement efforts provide for open and free competition among available bidders, and welcomes and encourages bids from small, minority and women business enterprises.

The City reserves the right to reject any and all bids, to waive informalities, and to award contracts in its best interest. No bid may be withdrawn after bid opening for a period of sixty (60) days thereafter.
