City of Hermitage (Owner) is requesting Bids for the construction of the following Project:

HERMITAGE ATHLETIC COMPLEX DEK HOCKEY FACILITY

Bids for the construction of the Project will be received at the office of the City Manager, Hermitage Municipal Building located at 800 North Hermitage Road, Hermitage, PA 16148, **until July 19, 2023 at 1:30 PM local time**. At that time the Bids received will be publicly opened and read. Proposals must be enclosed in a sealed envelope, addressed to the City of Hermitage City Manager and should bear the name and address of the Bidder, together with the words "Hermitage Dek Hockey Facility BID" This information should be clearly indicated on the exterior of the sealed envelope.

The Project includes the following Work:

Base Bid work consisting of fine grading, construction of two types of concrete pavement, installation of two trench drains, installation of a concrete band/flush curb, and construction of an asphalt trail.

Add Alternate 1 – 7 contain alternate bids for site preparation as outlined in the bid specifications.

The Project has an expected duration of **60** days from the date of issuance of the Notice to Proceed.

Contract documents will not be mailed or available for pickup at the City of Hermitage. The deadline to submit RFIs is July 14, 2023 at 1:00 pm.

Pre-bid Conference - A pre-bid conference for the Project will be held on **Monday, July 10 at 1:00 PM** at the City of Hermitage Municipal Building, 800 North Hermitage Road, Hermitage, PA 16148. Attendance at the pre-bid conference is encouraged but not required.

Commonwealth Finance Authority (CFA) - The project is being funded in part by a grant from the Pennsylvania Commonwealth Finance Authority (CFA). Bidders are required to comply with all applicable requirements of the grant program, including PA Prevailing Wage Rates.

Instructions to Bidders. - For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents. It is the proposing Bidder's responsibility to read the entire bid package and addenda and comply with all CFA funding requirements.
