- a) To abide by all applicable ordinances of the City of Hermitage, including but not limited to Chapter XXVII of the Hermitage Code of Ordinances, as amended.
- b) To construct and maintain the building sewer in accord with the requirements of the City of Hermitage and without cost to the City of Hermitage.
- c) To notify the Hermitage Inspection Department (724) 981-0800 when the building sewer is ready for inspection and connection to the public sewer.
NO WORK IS TO BE COVERED PRIOR TO INSPECTION
- d) If a private water source is used, and such water is to be deposited in the sanitary sewer, to pay the required deposit and permit the installation of a water meter on the private source of water. Residential use excluded.
- e) To obtain a permit for any excavation of the right-of-way.
