**PART 1**  
**GENERAL REGULATIONS**

**§ 15-101. Definitions and Interpretation. [Ord. 11-98, 9/23/1998]**

1. Words and phrases, when used in this chapter, except for sections or parts to which different or additional definitions apply, shall have the meanings ascribed to them in the Vehicle Code, the Act of June 17, 1976, P.L. 162, No. 81, as amended; except that in this chapter, the word "street" may be used interchangeably with the word "highway" and shall have the same meaning as the word "highway" as defined in the Vehicle Code.
2. The term "legal holidays," as used in this chapter, shall mean and include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.
3. In this chapter, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.

**§ 15-102. Manner of Adopting Permanent Traffic and Parking Regulations. [Ord. 11-98, 9/23/1998]**

All traffic and parking regulations of a permanent nature shall be enacted as ordinances, as parts of ordinances, as amendments to ordinances, or as amendments to this chapter, except where the law specifically authorizes less-formal action.

**§ 15-103. Provisions to be Continuation of Existing Regulations. [Ord. 11-98, 9/23/1998]**

The provisions of this chapter, so far as they are the same as those of ordinances and regulations in force immediately before the enactment of this chapter, are

intended as a continuation of those earlier ordinances and regulations and not as new enactments. Nothing in this chapter shall affect any act done or liability incurred, or any suit or prosecution pending or to be instituted, under any of those repealed or superseded ordinances or regulations.

**§ 15-104. Temporary and Emergency Regulations. [Ord. 11-98, 9/23/1998]**

1. The City Manager shall have the following powers to regulate traffic and parking temporarily and in time of emergency:
  - A. In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations; and
  - B. In the case of emergency or to facilitate public works, or in the conduct of parades, processions or public events, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.
2. Such temporary and emergency regulations shall be enforced by the Police Department in the same manner as permanent regulations. Any person who shall operate or park a vehicle or tractor in violation of any such regulations, or who shall move, remove, destroy, injure or deface any sign or marking erected, posted or made to give notice of any such regulation, shall, upon conviction thereof, be subject to the penalty set forth in the law or elsewhere in this chapter for a violation of such nature, and, in case of a violation for which no specific penalty is set forth in the law or elsewhere in this chapter, to a fine of not more than \$25, together with costs of prosecution.

**§ 15-105. Experimental Regulations. [Ord. 11-98, 9/23/1998]**

The Board of Commissioners may, from time to time, by resolution, designate places upon and along the highways in the City where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect and shall designate such locations by proper signs and markings. Such regulations, prohibitions and restrictions shall be effective as if they had been specified in this chapter. No person shall operate and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who shall violate any provision of this section shall, upon conviction thereof, be subject to the penalty set forth in the law or elsewhere in this chapter for a violation of such nature, and in case of a violation for which no specific penalty is set forth in the law or elsewhere in this chapter, to a fine of not more than \$25, together with costs of prosecution; provided, the purpose of this section is to allow for the test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the City relative to traffic and parking.

**§ 15-106. Traffic on Streets Closed or Restricted for Construction, Maintenance or Special Events. [Ord. 11-98, 9/23/1998]**

1. The Board of Commissioners shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion while construction or maintenance work is underway or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.
2. The Board of Commissioners shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is underway and to station flagmen at each end of the restricted portion. It shall be unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop or is signaling that vehicle, by a flag or other device, not to proceed.
3. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

**§ 15-107. Use of Streets by Processions and Assemblages. [Ord. 11-98, 9/23/1998]**

1. For the purpose of this section, the words "assemblage" and "procession" shall have the following meanings:

ASSEMBLAGE — A gathering of people, without vehicles, which interferes with the movement of pedestrian or vehicular traffic on any street.

PROCESSION — A group of individuals, vehicles, animals and/or objects moving along a street in a way that interferes with the normal movement of traffic. A procession shall not include a funeral caravan or military convoy.

2. It shall be unlawful for any person to hold or participate in any assemblage unless the person organizing or conducting the assemblage first obtains a permit from the City Manager, which shall be issued without fee. Application for the permit shall be made at least one week in advance of the day on which the assemblage is proposed to be held; but in any case where a state-designated highway is proposed to be used, application shall be made at least three weeks in advance of the proposed date. The permit shall state the place where and the date when the assemblage is to be held, the hour when the assemblage may convene and the hour by which it shall have been completely dispersed. It shall be unlawful for any person to hold or to participate in any assemblage unless the permit has been granted or at any time or place other than that authorized by the permit.
3. It shall be unlawful for any person to hold or participate in any procession unless the person organizing or conducting the procession first obtains a

permit from the City Manager, which shall be issued without fee. Application for the permit shall be made at least two weeks in advance of the day when the procession is proposed to be held; but in any case where a state-designated highway is proposed to be used, application shall be made at least three weeks in advance of the proposed date. The permit shall specify the date on which the procession is to be held, the route to be followed by the procession, the hour when and place where participants may commence to assemble and form before the procession is underway, the time when the procession may commence to move along its route, and the time by which the end of the procession shall have been disbanded. It shall be unlawful for any person to hold or to participate in any procession unless the permit shall have been granted or under any conditions as to time or route or otherwise than those stated in the permit.

4. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

**§ 15-108. Authority of Police Officers. [Ord. 11-98, 9/23/1998]**

The police officers of the City are hereby authorized to direct traffic on the highways of the City and at intersections thereof and to otherwise enforce the provisions of this chapter.

**§ 15-109. Authorization for Use of Speed-Timing Devices. [Ord. 11-98, 9/23/1998]**

1. The City Police Department is hereby authorized to use all speed-timing devices for the determination of speed of a motor vehicle as are approved or will be approved by the Department of Transportation of the Commonwealth of Pennsylvania, in accordance with Title 75 Pa.C.S.A. § 3368.
2. This section authorizes the use of said devices upon all highways within the City, be they City, county or state highways, and does also hereby elect to exercise all powers granted to "local authorities" under the Vehicle Code of the Commonwealth of Pennsylvania, 75 Pa.C.S.A. § 6101 et seq. (1977), as hereafter amended, supplemented, modified or reenacted by the General Assembly of Pennsylvania.

**§ 15-201. 1. Maximum speed limits are established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle, on any part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

**§ 15-214. Yield Intersections Established. [Ord. 11-98, 9/23/1998]**

1. The following intersections (in addition to intersections with the through highways established by § 15-212) are established as yield intersections, and official yield signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second-named street (the



through street) on the first-named street (the yield street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or yield street, in the direction indicated in each case, shall slow down or stop the vehicle as required by § 3323(c) of the Vehicle Code, and then yield the right-of-way as required by that subsection of the Vehicle Code.

**§ 15-215. Operation of Motor Vehicles Restricted on Public Lands. [Ord. 11-98, 9/23/1998]**

1. No motor vehicle including a motorcycle, pedalcycle or minibike shall be operated on any property owned by the City or any other public agency or instrumentality within the City without the permission of the property owner and a permit from the City Manager of the City.
2. Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.



## PART 3

**RESTRICTIONS ON SIZE, WEIGHT AND TYPE OF VEHICLE AND LOAD****§ 15-301. Authority. [Ord. 1-2013, 1/23/2013<sup>1</sup>]**

This Part is enacted and shall be administered and enforced in accordance with the authority set forth in Section 4902 and Chapters 63 and 65 of the Pennsylvania Vehicle Code, other applicable PennDOT regulations and other applicable laws and regulations, as amended from time to time.

**§ 15-302. Definitions. [Ord. 1-2013, 1/23/2013]**

Definitions set forth in Section 102 of the Pennsylvania Vehicle Code, 75 Pa. C.S.A. § 102, and the PennDOT regulations found at 67 Pa. Code § 189.1 et seq., as amended from time to time, shall apply in interpreting the provisions of this Part. Other definitions include the following:

CITY — The City of Hermitage, its Board of Commissioners and their duly appointed representatives.

LOCAL TRAFFIC — Includes emergency vehicles; school buses; vehicles of governmental agencies and utilities and their contractors engaged in maintenance or construction on a posted highway; and vehicles going to or coming from a residence, commercial establishment, or farm located on a posted highway. This definition shall incorporate definitions set forth in PennDOT regulations, as amended from time to time.

PENNDOT — The Pennsylvania Department of Transportation and its successors.

PERSON — Any individual, partnership, corporation, association, institution, cooperative enterprise, governmental entity or agency, or any other legal entity that is recognized by law. In any provision of this Part prescribing a fine or penalty, the term "person" shall include the officers and directors of any corporation or other legal entity having officers and directors.

**§ 15-303. Weight Limits for City Roads Established. [Ord. 1-2013, 1/23/2013; as amended by Ord. 5-2013, 9/25/2013]**

Based on the results of engineering studies, the weight limits set forth are the weight limits for vehicles and combinations established for the City roads and portions thereof identified below.

**§ 15-304. Overweight Vehicles Prohibited on Designated City Roads. [Ord. 1-2013, 1/23/2013]**

No vehicle or combination, including but not limited to any truck, tractor, trailer, semi-trailer, commercial vehicle, construction equipment, or other vehicle or equipment, with a gross weight in excess of the weight limit established by this Part shall be operated on a City road that is subject to a weight restriction imposed by this Part unless exempt or operating under a permit as provided in this Part.

**§ 15-305. Exemptions. [Ord. 1-2013, 1/23/2013]**

The following vehicles shall be exempt from the weight restrictions imposed by this Part: emergency vehicles, school buses, and local traffic as defined in the applicable PennDOT regulations. If the City determines that local traffic being driven to or from a particular destination is likely to damage the road, then, upon notice required by law, vehicles with a gross weight in excess of the weight limit using the posted road to or from that destination shall not be exempt. Vehicles used in the oil and gas drilling and extraction process, and logging, are not and shall not be exempt from the weight limit restrictions as local traffic.

**§ 15-306. Permits and Bonds Required for Use by Overweight Vehicles. [Ord. 1-2013, 1/23/2013]**

Any person desiring to operate or to move any truck, tractor, trailer, semi-trailer, commercial vehicle, construction equipment or other vehicle or equipment of any nature whatsoever in excess of the weight limits provided herein over the City roads restricted as to weight as herein provided, with the specific exemptions set forth above, shall apply to the City for a permit for the movement of such vehicle in the manner established by this Part. If it is determined by the City that such movement requested by the applicant for the permit can be made without causing excessive damage to the road or the destruction of the road or a traffic hazard to other users of the road and the public, then the City may grant such permits subject to and conditional upon the execution of an excess maintenance agreement in the form approved by the City, the provision of security in the nature of a surety bond or other security approved by the City for the protection of the City and the road, and the performance of all other requirements imposed by the applicable Pennsylvania Department of Transportation regulations relating to hauling in excess of posted weight limits, as amended, and such other reasonable conditions as may be appropriate under the circumstances.

**§ 15-307. Requirements for permits. [Ord. 1-2013, 1/23/2013]**

1. An application for a permit shall be submitted on forms to be provided by the City, to the City Manager, together with such fee as shall be established by resolution of the Board of Commissioners. The application shall include a description of all motor vehicles and equipment to be used in the transportation of materials and materials to be transported. Such list shall include, among other things, each vehicle's manufacturer, state of registration, registration number, plate number, weight classification, model, color, and titled owner.

2. Upon determination that a permit should be granted, the City shall inspect the subject road(s), prepare an inspection report, and obtain the required security and properly executed excess maintenance agreement before issuing the permit.
3. Before the permit may be issued, the City shall be provided with security in the form of a bond or other security that complies with applicable regulations.
4. Before the permit may be issued, the person receiving the permit shall execute and deliver to the City an excess maintenance agreement, substantially in the form of the agreement adopted from time to time by the

Board of Commissioners, and which is reasonably required to meet applicable state and local regulations.

5. The City may impose conditions or restrictions on the permit as may be reasonable and necessary for the protection of the road and the public, such as, but not limited to, time and manner of use.
6. The City shall maintain all records relating to any permit granted for so long as the permit remains in effect and for a reasonable time thereafter.

**§ 15-308. Enforcement. [Ord. 1-2013, 1/23/2013]**

Enforcement of this Part shall be by action brought before a District Magistrate in the manner provided for the enforcement of summary offenses under the applicable sections of the Pennsylvania Vehicle Code and of the Pennsylvania Rules of Criminal Procedure and in any other manner permitted by law.

**§ 15-309. Penalty for Violation. [Ord. 1-2013, 1/23/2013]**

Any person operating or responsible for operation of a vehicle or combination upon a road in violation of the prohibitions and restrictions set forth in this Part, or in violation of the terms of a permit issued in accordance with this Part, shall be guilty of a summary offense and shall, upon conviction thereof, be sentenced to pay a fine of \$75, plus \$150 for each 500 pounds, or part thereof, in excess of 3,000 pounds over the maximum allowable weight. In default of payment of the fine, such person shall be sentenced to up to 10 days in prison.

**§ 15-310. Severability. [Ord. 1-2013, 1/23/2013]**

It is hereby declared to be the intent of this Part that the provisions hereof are severable; and in the event that any section of this Part or part thereof should be declared unlawful or unconstitutional, the balance of this Part shall continue in full force and effect as though said unlawful or unconstitutional provision had been omitted at the original passage of this Part.



## PART 4

## GENERAL PARKING REGULATIONS

**§ 15-401. Vehicles to be Parked Within Marked Spaces. [Ord. 11-98, 9/23/1998]**

Wherever a space is marked off on any street for the parking of an individual vehicle, every vehicle parked there shall be parked wholly within the lines bounding that space, and it shall be a violation of this Part for any person to park a vehicle or allow it to remain parked otherwise.

**§ 15-402. Parking Prohibited at All Times in Certain Locations. [Ord. 11-98, 9/23/1998; as amended by Ord. 24-99, 9/22/1999, § 1; and by Ord. 4-2001, 4/25/2001, § 1; and by Ord. 13-2016, 12/21/2016]**

Parking shall be prohibited at all times in the following locations:

**§ 15-403. Parking Prohibited in Certain Locations, Certain Days and Hours.**  
**[Ord. 11-98, 9/23/1998; as amended by Ord. 24-99, 9/22/1999, § 1]**

Parking shall be prohibited in the following locations at all times on the days and between the hours indicated in this section, as follows:

**§ 15-404. Penalties. [Ord. 11-98, 9/23/1998]**

Any person who violates any provision of this Part shall, upon conviction, be sentenced to pay a fine of not more than \$15 and costs; provided that it shall be the duty of the police officers and of parking enforcement personnel of the City to report to the appropriate official all violations of any provision of this Part, indicating, in each case; the section violated; the license number of the vehicle involved in the violation; the location where the violation took place; and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Part. The notice shall contain instructions to the owner or driver of the vehicle that if he will report to the office of the Chief of Police and pay the sum of \$15 within 48 hours after the time of the notice, or if he will place

the sum of \$15, enclosed within the envelope provided, in any of the special parking fine boxes installed at various locations within the City, that act will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this section.



## PART 5

## SNOW AND ICE EMERGENCY

**§ 15-501. Declaration of Snow and Ice Emergency. [Ord. 11-98, 9/23/1998]**

In order to facilitate the movement of traffic and to combat the hazards of snow and ice on the snow emergency routes named in § 15-503 of this Part, the City Manager, in his discretion, may declare a snow and ice emergency (designated in this Part as a "snow emergency"). Information on the existence of a snow emergency shall be given by the City through radio, newspaper or other available media, and information on the termination of the emergency may be given by use of the same media.

**§ 15-502. Parking Prohibited, Driving Motor Vehicles Restricted, on Snow Emergency Routes During Emergency. [Ord. 11-98, 9/23/1998]**

After any snow emergency is declared, it shall be unlawful, at any time during the continuance of the emergency, for any person:

- A. To park a motor vehicle or to allow that vehicle to remain parked anywhere on any snow emergency route designated in § 15-503 of this Part; or
- B. To drive any motor vehicle on any such snow emergency route, unless that vehicle is equipped with snow tires or chains.

**§ 15-503. Snow Emergency Routes Designated. [Ord. 11-98, 9/23/1998]**

The following are designated as snow emergency routes:

**§ 15-504. Penalty For Violation. [Ord. 11-98, 9/23/1998]**

1. If, at any time during a period of snow emergency declared under § 15-501 of this Part, a person shall park a motor vehicle or allow a motor vehicle to remain parked anywhere upon a snow emergency route, that person shall be guilty of a violation of this Part and, upon conviction, shall be sentenced to pay a fine of not more than \$15 and costs.
2. If, at any time during a period of snow emergency declared under § 15-501 of this Part, a person shall drive a motor vehicle upon a snow emergency route without having that vehicle equipped with snow tires or chains, that person shall be guilty of a violation of this Part and, upon conviction, shall be sentenced to pay a fine of \$25 and costs.



PART 6  
FIRE LANES

**§ 15-601. Purpose. [Ord. 11-98, 9/23/1998]**

The purpose of this Part is to set forth regulations governing the establishment, enforcement and maintenance of fire lanes area within the City of Hermitage and to provide for the punishment of violations of this Part.

**§ 15-602. Designation of Fire Lanes. [Ord. 11-98, 9/23/1998]**

The Fire Marshal shall require and designate public or private fire lanes as deemed necessary for the efficient and effective operation of fire apparatus. Fire lanes shall have a minimum width of 18 feet (5486 mm).

**§ 15-603. Temporary Fire Lanes. [Ord. 11-98, 9/23/1998]**

The Fire Marshal may, because of weather conditions, dangerous conditions or construction conditions, designate temporary fire lanes.

**§ 15-604. Stopping, Standing, and Parking Prohibited in Established Fire Lanes. [Ord. 11-98, 9/23/1998; as amended by Ord. 7-99, 3/24/1999, § 1; by Ord. 13-2003, 7/30/2003; by Ord. 11-2005, 10/26/2005; by Ord. 6-2006, 7/26/2006; and by Ord. 5-2007, 8/22/2007]**

It shall be unlawful for any person to stop, stand or park an unauthorized vehicle in any of the following established fire lanes or in any temporary fire lane, at any time:

- A. 2191 East State Street, the entire west and north side of the building to a width of 18 feet from the curb and along the east side of the access driveway from East State Street to the building.
- B. 2199 East State Street, the entire south side of the building to a width of 18 feet from the curb (or structure), except for a properly marked "customer loading zone" area approved by the Fire Marshal, and along all access driveways from the public highway to the parking lot area.
- C. 2120 Shenango Valley Freeway (Kennedy Christian High School), the entire north, east and south sides of the building to a width of 18 feet from the curb (or structure) and along all access driveways from the public highway to the parking lot.
- D. 2235 to 2499 East State Street (Hermitage Towne Plaza), the entire perimeter of the building to a width of 18 feet from the curb (or structure) and along all access driveways from the public highway to the parking lot areas.

- E. 2250 Shenango Valley Freeway (John XXIII), the entire north, west and south sides of the building to a width of 18 feet from the curb (or structure) and along all access driveways from the public highway to the parking lot areas, including the driveway from the Kennedy Christian High School to the west side of this building.
- F. 500 Clarksville Road, the northwest (front) and west (rear) sides of the building to a width of 18 feet from the curb (or structure).
- G. 3726 East State Street, the entire perimeter of the building to a width of 18 feet from the curb (or structure).
- H. 2325 Highland Road (Notre Dame School), the entire north, west and south sides of the building to a width of 18 feet from the curb (or structure) and along the access driveways from the public highway to the parking lot areas.
- I. 2982 to 2936 East State Street (Hermitage Hills Plaza), the entire perimeter of the building to a width of 18 feet from the curb (or structure) and along the access driveway from East State Street to the parking lot areas.
- J. 2998 East State Street, the entire east (front) side of the building to a width of 18 feet from the curb (or structure).
- K. Freeway, the entire north (front), south and west side to a width of 18 feet from the curb (or structure) and along all access driveways from the public highway to the parking lot areas.
- L. Hermitage Square Shopping Center, the entire perimeter of the building to a width of 18 feet from the curb (or structure) and along all access driveways from the public highway to the parking lot areas.
- M. 3320 East State Street, the entire perimeter of the building to a width of 18 feet from the curb (or structure).
- N. 1 South Hermitage Road, the entire perimeter of the building to a width of 18 feet from the curb (or structure).
- O. United States Post Office, Hermitage Square Shopping Center, the entire perimeter of the building to a width of 18 feet from the curb (or structure).
- P. Hermitage School District:
  - (1) 123 North Hermitage Road (Hermitage Middle School), the entire south and west sides of the building to a width of 18 feet from the curb (or structure) and along the driveway on the south side of the building.
  - (2) 233 North Hermitage Road (Hermitage Elementary), the entire south and east sides of the building to a width of 18 feet from the curb (or structure) and along the access driveway from North Hermitage Road past the Hermitage Elementary building to the Artman parking area.



- (3) 343 North Hermitage Road (Artman Elementary), the entire east and south sides of the building to a width of 18 feet from the curb and along the access driveway from the North Hermitage to the Artman building.
  - (4) 419 North Hermitage Road (Delahunty Elementary), the entire east and north sides of the building to a width of 18 feet from the curb (or structure) and along the access highway from Highland Road to the parking area on the north side of the building.
  - (5) 640 North Hermitage Road (Hickory High School), the entire perimeter of the building to a width of 18 feet from the curb (or structure) and along the driveway on the north and south sides of the building and along any access road to the athletic areas at the rear of the building.
- Q. Shenango Valley Mall, the entire perimeter of the building to a width of 18 feet from the curb (or structure) and along all access driveways from the public highway to the parking lot areas.
- R. 3000 Glimcher Boulevard (Lowes), the entire perimeter of the building to a width of 18 feet from the curb (or structure), excluding all designated and signed areas for loading and unloading and customer merchandise pickup.
- S. 2511 Highland Road (Hermitage Central Fire Station), the entire width and length of the access drives leading to and from the public highway to parking lots and fire apparatus egress doors, ramps and drives leading from the south side of the building to the public highway.
- T. 541 Mercer Avenue (Hermitage Volunteer Fire Department), the entire width and length of the fire apparatus egress doors, ramps and drives leading from the north side (front) of the building to the public highway.
- U. 2400 Garden Way (Bently Assisted Living Center), the entire length of the access drive leading off of Garden Way southward and then westward in all areas of the access drive and parking lot of the facility not specifically signed, designated or pavement striped as a designated resident, visitor or disabled, loading/unloading zone, and as posted by the proper signs and pavement striping.
- V. 119 Superior Street (Patagonia Volunteer Fire Department), the entire width and length of the access drives and alleyways leading to and from the public highway to the parking lots and fire apparatus egress doors, ramps and driveways, on the north sides of the building leading to the public highway, and as posted by the proper signs and pavement stripping.
- W. 1760 - 1800 Broadway Road (Chambers Steel and Turner Steel), 100 feet north and south of the access road leading into the stated properties on Broadway Road proper, east and west side of the roadway; the private access road leading into the properties known as Turner Steel, 1760 Broadway

Road, and Chambers Steel, 1800 Broadway Road; on the north and south sides of the private access road from the public roadway on the south side of the road to a point of 185 feet; then on the north side of the leading from the public roadway to a point of 150 feet west, as illustrated on the attached drawing.

- X. 1275 North Hermitage Road (Super Wal-Mart). The entire perimeter of the building to a width of 18 feet from the curb or structure, excluding two designated and properly marked customer loading zones of approximately 50 feet in length each, and along the north driveway beginning at a point approximately 200 feet from North Hermitage Road for a distance of approximately 150 feet on both sides of the driveway, as illustrated on the attached drawing.
- Y. Hermitage Crossing.
- (1) 1065, 1075, 1085, 1091, and 1101 North Hermitage Road (Hermitage Crossing). The entire south (rear) access driveway, and along the entire length of the rear of the building for approximately 198 feet, extending 18 feet from the south wall of the building except for designated and properly marked loading areas as illustrated on the attached drawing.
  - (2) 1109, 1115, 1121, 1127, 1133, 1139, 1145, 1149, 1155, 1163, 1167, 1169, and 1179 North Hermitage Road (Hermitage Crossing). The entire east (front) side of the building, a distance of approximately 430 feet, extending from the building curbline to parking lot curbline, a distance of approximately 30 feet and all areas within the access driveway as illustrated on the attached drawing.
  - (3) 1109, 115, 1121, 1127, 1133, 1139, 1145, 1149, 1155, 1163, 1167, 1169, and 1179 North Hermitage Road (Hermitage Crossing). The entire west (rear) side of the building, a distance of approximately 450 feet, extending approximately 18 feet from the building, except for designated and properly marked loading areas, and all areas within the access driveway as illustrated on the attached drawing.
- Z. 3300 Shenango Valley Freeway (Home Depot). The entire perimeter of the retail sales building to a width of 18 feet from the curb or structure and along all access driveways from the public highway to the parking lot areas where marked and identified by signage and/or pavement markings as fire lanes.
- AA. 570 South Hermitage Road (Kohl's). An area on the north side (front) of the building extending 31 feet from the curb a distance of 360 feet, an area on the west side extending 28 feet from the curb a distance of 210 feet and on the south side (rear) of the building, extending 35 feet from the building a distance of 360 feet, excluding areas designated by proper signage and markings identifying for vehicle parking and loading/unloading, are

established and designated with proper signage and pavement markings as fire lanes. **[Added by Ord. 2-2013, 3/27/2013]**

**§ 15-605. Authorized Vehicles. [Ord. 11-98, 9/23/1998]**

The following vehicles are authorized to park in designated fire lanes subject to listed circumstances:

- A. Emergency vehicles, including fire/rescue, police and emergency medical services, when parked during emergency situations or when enforcing the provisions of this Part.
- B. Vehicles transporting students, at school buildings, when in the process of picking up or dropping off students.

**§ 15-606. Approved Signs and Markings. [Ord. 11-98, 9/23/1998]**

All signs and markings shall be of a type and design and shall be installed and posted in accordance with the regulations adopted by resolution of the Board of Commissioners of the City of Hermitage.

**§ 15-607. Maintenance of Signs and Markings. [Ord. 11-98, 9/23/1998]**

All designated fire lane signs and markings shall be maintained in clean, legible and easily visible condition at all times by the property owner.

**§ 15-608. Penalties. [Ord. 11-98, 9/23/1998]**

1. Any person who violates any provision of this Part shall, upon conviction, be sentenced to pay a fine of not more than \$15 and costs; provided that it shall be the duty of the police officers and of parking enforcement personnel of the City to report to the appropriate official all violations of any provision of this Part, indicating in each case the section violated, the motor vehicle registration number of the vehicle involved in the violation, the location where the violation took place, and any other facts that may be necessary in order to secure a clear understanding of the circumstances attending to the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Part. The notice shall contain instructions to the owner or operator of the vehicle that he must report to the Hermitage Police Department and pay the sum of \$15 within 48 hours after the time of the notice or place the sum of \$15 enclosed within the envelope provided and mail it to the Hermitage Police Department, postmarked within 48 hours after the time of such notice. Such payment will avoid prosecution and payment of the fine prescribed in Subsection 2 of this section.
2. Any person, firm or corporation who shall violate any provision of this Part, and who fails to pay the fine established in Subsection 1 of this section, shall be, upon conviction thereof, sentenced to a fine not more than \$600 plus costs

and, in default of said fine and costs, to a term of imprisonment not to exceed 30 days.

## PART 7

**JAKE BRAKES****§ 15-701. Definitions. [Ord. 13-2002, 12/18/2002, § 1]**

The following words and phrases, when used in this Part, shall have the following meanings:

JAKE BRAKING — The use of compression release engine brakes to slow a truck without using the normal brake system.

**§ 15-702. Prohibited in Specified Area. [Ord. 13-2002, 12/18/2002, § 2; Ord. No. 9-2023, 12/20/2023; Ord. No. 2-2024, 1/2/2024]**

No person operating a truck within the City of Hermitage shall use the process of "jake braking" to slow his/her truck on Route 18 (North Hermitage Road) from the City line south to a point 0.5 miles south of Longview Road, or on the entire length of Broadway Avenue from the Shenango Township line to the Farrell City line.

**§ 15-703. Emergency Response Vehicles. [Ord. 13-2002, 12/18/2002, § 3]**

This Part does not apply to emergency response vehicles, including, but not limited to, fire and rescue vehicles and equipment.

**§ 15-704. Erection of Signs. [Ord. 13-2002, 12/18/2002, § 4]**

The City of Hermitage shall erect official traffic control devices along the roadway designated in § 15-702 of this Part to alert drivers of the prohibition against "jake braking." Such devices will be of a type and be erected at location as required by the Pennsylvania Motor Vehicle Code and be in conformity with the regulations of the Pennsylvania Department of Transportation, as the same may be amended.

**§ 15-705. Penalty. [Ord. 13-2002, 12/18/2002, § 5]**

Any person violating any provisions of this Part shall, upon conviction thereof, be guilty of a summary offense and be subject to pay a fine not to exceed \$1,000 and, in default of such payment, be subject to imprisonment for a period not to exceed 90 days.
